While reviewing the court cases, it has been observed that objections in large number of contempt petitions and court cases have not been filed. The same have not been pursued/followed properly by the sub-ordinate formations under the Administrative Control of Industries and Commerce Department. In number of cases, the decisions of the single bench have also not been implemented properly resulting into sizable number of contempt petitions. In order to streamline the process and properly monitor the court cases, it is enjoined upon all the Heads of the Departments/Corporations/Institutes/Board falling under the Administrative Control of Industries and Commerce Department and officials within the secretariat, that:

- a) they shall convene fortnightly meetings to review the progress of filling objection and replies in the Court Cases within their respective offices;
- b) they shall personally see the 'Cause-list' published on the web-site of the High Court every week and take action promptly;
- c) Commissioner/Secretary to Government, Industries and Commerce department shall review the progress on Court Cases on 10th of every month;


In case the slackness on the part of any officer/official results in contempt proceedings initiated against the Commissioner/Secretary to Government, Industries and Commerce Department in any court case(s), the same shall be reflected in the Annual Performance Reports (APRs) of the officer/official due to whose delinquency/negligence, the same has been got initiated by the Hon'ble Court(s).
