Sanction is hereby accorded to the release of Rs.436.87 lakh (Rupees Four crore thirty six lakh eighty seven thousand only) on account of 3rd installment of Grant-in-Aid in favour of Secretary Khadi & Village Industries Board J&K, Jammu to defray expenses on account of salary, pension etc. of its employees during the current financial year 2016-17.

Sanction is also accorded to the advance drawal of the said amount of Rs. 436.87 lakh (Rupees Four crore thirty six lakh eighty seven thousand only) by the Director Finance, Industries & Commerce Department for its further placement at the disposal of Secretary Khadi & Village Industries Board J&K, Jammu. The expenditure shall be booked by Secretary J&K, KVIB after fulfillment of the following conditions:-

1. No vacant post shall be filled up either by promotion or by direct recruitment.
2. Reduce the expenditure on TE, OE, POL by 15% of last years level.
3. No vehicle shall be purchased during the current financial year.
4. Expected income and expenditure details for the current financial year be furnished to the Administrative Department / Finance Department.
5. All the UC's /Red Accounts of the previous amount if any pending shall be submitted to the AG on priority and the OB items if any pending for want of UC's/ Red Accounts of previous amounts shall be cleared from the AG's office immediately.

Total funds released on account of Grant-in-Aid during the current financial year 2016-17 is Rs. 1310.61 lakh only.
