Sanction is hereby accorded to the release and advance drawal of funds amounting to Rs.131.26 lakh (Rupees One Crore Thirty-one lakh Twenty-six thousand) only as Plan Assistance under Capex Budget, 2016-17 in favour of Director Finance, Industries and Commerce Department for its further placement at the disposal of the Managing Director, J&K Handloom Development Corporation Ltd. for implementation of approved schemes during the current financial year 2016-17.

With this sanction, the total amount released in favour of Managing Director, J&K Handloom Dev. Corporation under Capex Budget 2016-17 comes to Rs. 262.50 lakh (Rupees Two Crore Sixtytwo Lakh and Fifty thousand only) till date.

2. UCs/Red accounts of the funds being released shall be furnished to all the concerned quarters including Principal Accountant General J&K.
3. The Corporation shall clear O.B items (if any) from Accountant General's Office.
4. Managing Director, Handloom Dev. Corporation shall utilize the funds only for the purpose for which these have been released after observing all codal formalities and no diversion / re-appropriation of funds is allowed in any case.
5. The implementation of work Plan 2016-17 is subject to the approval by Board of Directors of the Corporation.
6. The Administrative approval / Technical sanction shall be obtained wherever required before incurring of expenditure.
7. The utilization certificate is furnished to the Administrative Department after expenditure is incurred.
