Sanction is accorded to the release and advance drawal of funds amounting to ₹93.50 Lakh (Rupees Ninety-three Lakh Fifty Thousand) only as Plan Assistance under Capex Budget. 2016-17 in favour of Director Finance, Industries and Commerce Department for its further placement at the disposal of Managing Director, J&K Industries Ltd. for implementation of approved schemes during the current financial year 2016-17.

With this sanction, the total amount released in favour of Managing Director, J&K Industries Ltd under Capex Budget 2016-17 comes to Rs187.25 lakh (Rupees One Crore Eighty-Seven Lakh Twenty-five thousand only) till date.

The release / advance drawal is subject to the following conditions:-

- the amount is utilized only on approved schemes duly authorized / approved by the BoDs;
- the funds shall be utilized for the purposes they are released.
- the utilization certificate/ Red Accounts shall be furnished to the Administrative Department after the expenditure is incurred.
- the advance money is not blocked unnecessarily.
- no diversions shall be made from one object head to another.
- the material rendered surplus by dismantling the already created infrastructure, if any, is properly accounted for.
- the works are to be executed as per approved specifications / design and completed within the estimated cost
- the works will be executed after observing all codal / procedural formalities.
- Managing Director, JK Industries Ltd. shall vouch safe utilization of funds.
