The released of funds shall be subject to the following conditions:-

- (i) The release of funds shall not be taken as final authority for utilization and the Director should satisfy himself to ensure optimum utilization of funds;
- (ii) The Director shall also ensure that the funds released are utilized prudently and judiciously and in no case the Department should book the expenditure just for the sake of spending;
- (iii) The expenditure shall be incurred only after observing all codal procedure/ formalities required under rules to avoid financial indiscipline;
- (iv) The expenditure shall be restricted to the Administratively approved cost of the project/work;
- (v) No diversion/re-appropriation of funds shall be made from one object head to another at any cost;
- (vi) The funds shall be utilized for the approved works only under Special Task Force during the current financial year;
- (vii) The utilization certificate of the funds released shall be furnished to the Administrative Department after incurring the expenditure.
