**Sanction is hereby accorded to the:-**

- (i) withdrawal of an amount of Rs 92.07 lakh (Rupees ninety two lakh seven thousand) only re-appropriated from the scheme "Establishment/Development of New Industrial Estates" under Capex Budget, 2016-17- MSME & LI, Kashmir towards clearing the liability on account of land at Salamabad (Uri), District Baramulla under the possession of Industries & Commerce Department where from Trade Facilitation Centre is operating; and
- (ii) release of an amount of Rs 92.07 lakh (Rupees ninety two lakh seven thousand)only in favour of Deputy Commissioner, Baramulla (Collector Land Acquisition) for disbursement of payments among land owners in compliance to the Hon'ble Court directions passed by Ld. Principal District Judge, Baramulla on 19-12-2016 in an Execution petition by Ghulam Rasool Wathloo and Ors V/S State and Ors on account of compensation of land presently under the possession of Industries & Commerce Department at Salamabad (Uri), District Baramulla where from Trade Facilitation Centre is operating.

The release of funds is subject to the following conditions:-

- (1) The funds shall be utilized for the purpose specified for which these are released;
- (2) All codal formalities/procedures shall be adhered to strictly before funds are utilized;
- (3) No diversion/re-appropriation/retention of funds shall be made at any level.

The expenditure shall be debitable to the following object Heads:-
