Sanction is accorded to the release/advance drawl of Rs. 500.00 Lakh (Rupees Five Crore only) out of Budget Estimates for the Financial Year 2017-18 authorized by the Finance Department vide No.FD-VII-11(1 24) 2005 dated 12.06.2017 in favour of Director Finance, Industries & Commerce Department for further placement of these funds at the disposal of Director, Entrepreneurship Development Institute falling under the Administrative control of Industries & Commerce Department for meeting the salaries and other authorized expenditure of the Institute.

The above authorization/ utilization of funds by the Director, EDI is subject to the following Condition:

- 1- The Funds shall be utilized on committed items for the bona fide purpose only with the approval by the Governing Body of the Institute.
- 2- The Director, EDI shall ensure that the funds released are utilized prudently and judiciously under rules and in no case the Institute should book the expenditure just for the sake of spending.
- 3- All codal formalities and financial rules/orders and instrupctions issued by the Government from time to time shall be observed while incurring the expenditure against the allocated budget.
- 4- The Director, EDI shall submit utilization certificate of the funds released soon after the utilization.
- 5- No re-appropriation/diversion/retention of funds is allowed in any case.
- 6- The ceiling under above authorized Object Head shall be kept within the authorized/adopted figures under Budget Estimates 2017-18 by the Finance Department.
- 7- UC's/Red accounts of the funds being released shall be furnished to all the concerned quarters including Principal Accountant General, J&K.

*The expenditure on this account shall be classified as under:-*

- i) Demand No. = 11-Industries & Commerce Department.
- ii) Head of Department= 06- Commr./Secretary to Govt. I&C Department.
- iii) Major Head: = 2851-Village & Small Industries.

- x) Sub Head: = 2196-EDI.
- xi) Detailed Head = 028-Grant-In-Aid.
