Revised Administrative Approval is accorded to the Construction of Sanat Ghar (Udyog Bhawan) at Bemina, Srinagar at a revised cost of ₹32.60 Crore (Rupees Thirty-two Crore Sixty Lakh) only as per the estimates vetted by the Development Commissioner, Works indicated in appended Annexure-"A" to the Government Order

The Accord of Revised Administrative Approval is subject to the following conditions. -

- i- That the proposal was strictly devised and designed as per relevant code BIS/IRC/MORD/MORTH Manual/specifications with special emphasis on earth quake resistance of structures;
- ii- That any such item(s) not covered under relevant Schedule of Rates have been/shall be paid in accordance with the set codal procedure;
- iii- That the structural design of the structures were got approved from the Competent authority with proof checking of design conducted on ground;
- iv- That the items related to the quantity of earthwork wherein conformity with authenticated NSLs, design Cross sections and L-sections. Moreover pavement design was based on CBR test results;
- v- That the procedure for obtaining NoC from the concerned Regulatory Authorities have been followed before execution of work;
- vi- That third party quality control of the project has been conducted during and after the execution of work; and
- vii- That all codal formalities ; procedure have been followed.
