3. no diversions are made and all codal / procedural formalities are adhered to before utilizing the funds;

4. the material rendered surplus by dismantling the already executed works, if any, shall be properly accounted for in the books of accounts;

5. that the release of next installment shall be contingent upon full utilization of these funds and rendition of utilization certificates;

6. the Managing Director, J&K Minerals Ltd. shall vouch safe utilization of funds;

7. Financial Advisor, J&K Minerals Ltd. shall monitor progress of expenditure and ensure that cannons of financial property are strictly adhered.
