Sanction is hereby accorded to the release and advance drawal of funds amounting to Rs.53.50 Lakh (Rupees Fiftythree lakh fifty thousand) only as Plan assistance under Capex Budget, 2017-18 in favour of Director Finance, Industries and Commerce Department for its further placement at the disposal of the Managing Director, J&K SICOP Ltd. for implementation of approved schemes during the current financial year 2017-18.

The release / advance drawal is subject to the following conditions:-

1. the amount is utilized only on approved schemes duly authorized by the Board of Directors of the Corporation ;
2. no expenditure is incurred on any scheme / project, if not administratively approved and technically vetted by the competent authority;
3. no diversions are made and all codal / procedural formalities are adhered to before utilizing the funds;
4. the material rendered surplus by dismantling the already executed works, if any, shall be properly accounted for in the books of accounts;
5. that the release of next installment shall be contingent upon full utilization of these funds and rendition of utilization certificates;
6. the Managing Director, J&K SICOP shall vouch safe utilization of funds;
7. Financial Advisor, J&K SICOP shall monitor progress of expenditure and ensure that cannons of financial property are strictly adhered.

The expenditure shall be debit able to the object Heads:-

1. Major Head = 4852 -Capital Outlay on Iron & Steel Industries
2. Sub-Major Head= 02—Manufacture
3. Minor Head = 190—Investment in Public Sector & other Undertakings.
4. Group Head = 0011- State Plan normal
5. Sub-Head = 1224- SICOP.
6. Detailed Head = 400-Plan Assistance
