- 2) The Department shall furnish Utilization Certificate/Red Accounts of the funds to all the concerned quarters including Principal Accountant General.
- 3) The advanced money is not blocked unnecessarily and no diversion/re-appropriation at any level shall be allowed.
- 4) The Department shall vouch safe the availability and utilization of funds under Capex Budget.


