Sanction is hereby accorded to the release of Rs.43.75 Lakh (Rupees Forty Three Lakh Seventy Five Thousand only) as 2<sup>nd</sup> installment of Grant-In-Aid in favour of Managing Director, J&K, and Handicrafts (S&E) Corporation for meeting the salary/wages bill of its employees during the current financial year (2017-18).

Sanction is also accorded to the advance drawal of the above amount by the Director Finance, Industries and Commerce Department and its further placement at the disposal of Managing Director, J&K, and Handicrafts (S&E) Corporation. The up to date funds released in favour of the Corporation is Rs.87.50 Lakh.

The funds so provided shall be utilized for the bonafide purpose, and shall not be diverted for any other purpose.

The current EPF/CPF shall be first charge on this amount so released and after paying the same the balance is to be utilized by the Corporation.

**The following conditions shall be strictly adhered to:-**

- 1- No post shall be filled up either by promotion or recruitment.
- 2- No new allowances will be given including COLA/DA.
- 3- Avenues for raising additional resources be explored.
- 4- Expected income and expenditure details for the current financial year be furnished to the Administrative Department/Finance Department.
- 5- All the UC/s /Red Accounts of the previous amount if any pending shall be submitted to the AG on priority and the OB items if any pending for want of UCs/Red Accounts of previous amounts shall be cleared from the AG's office immediately.

**Expenditure on this account shall be classified as under:-**

Major Head = 2851 -Village and Small Industries.  
Sub Major Head = 00 -  
Minor Head = 001- Direction and Administration.  
Group Head = 0099 -General  
Sub Head = 1211 - Assistance to Public Sector Units.  
Detailed Head = 028- Grant-In Aid
