Ex-post facto sanction, in relaxation of Jammu and Kashmir Civil Services (Medical Attendance-cum-Allowances) Rules, 1990, is hereby accorded to the reimbursement of medical expenses in favour of Shri Shakeel Ahmad Rather, Assistant Handicrafts Training Officer (AHTO), Handicrafts, incurred on self treatment at Institute of Liver & Biliary Sciences, New Delhi, subject to the following conditions:-

- i) That the reimbursement of expenses shall be restricted to items/procedures admissible under rules for the period of hospitalization and cost thereof restricted as per rates applicable to such items/procedures at AIIMS, New Delhi.
- ii) That all relevant medical bills/vouchers are verified and countersigned by the competent medical authority of the hospital wherefrom treatment has been taken.
- iii) That in case, the patient wants to still take treatment at the Institute of Liver & Biliary Sciences, New Delhi, the reimbursement shall be restricted at rates prevailing at A.I.I.M.S for such treatment.
