Sanction is accorded to the:-

- i. Release of an amount of Rs 5.00 lakh (Rupees Five lakh) only as 50% of the approved allocation under the scheme "Up-gradation/Maintenance of Udyog Bhawan Jammu and Sanat Ghar, Srinagar (Wi-Fi, CCTV, data centre etc)" in favour of Director Finance, Industries & Commerce Department, under Capex Budget, 2017-18 of J&K Minerals Ltd;
- ii. advance drawl of these Rs 5.00 lakh (Rupees Five lakh) only by Director Finance, Industries & Commerce Department for its placement with Managing Director, J&K SICOP for implementation of the scheme "Up-gradation/Maintenance of Udyog Bhawan Jammu and Sanat Ghar, Srinagar (Wi-Fi, CCTV, data centre etc)"

With this sanction, the total amount released under the scheme comes to Rs 10.00 lakh (Rupees Ten lakh) till date.

The release/advance drawal of funds shall be subject to the following conditions:-

- i- the Managing Director, J&K SICOP shall utilize the funds only after completing all codal formalities required under rules;
- ii- no re-appropriation/diversion/retention of money is allowed in any case;
- iii- the utilization certificate of the funds released shall be submitted to Administrative Department soon after utilization;

Managing Director, J&K SICOP shall vouchsafe the utilization of funds.

The expenditure shall be debitale to the following object Heads:-

- i. Demand No. = 11
- ii. Major Head = 4853- Capital outlay on Non-ferrous Minerals & Metrological Industries
- iii. Sub-Major Head = 01- Mineral Exploration and Development
- iv. Minor Head = 190-Investment in Public & other Undertakings
- v. Group Head = 0011- State Plan Normal
- vi. Sub Head = 0377- J&K Minerals Ltd.
- vii. Detailed Head = 400-Plan Assistance
