In terms of circular issued by the Finance Department vide No A/12(73)W-557 dated 30-06-2009, post facto sanction is accorded to the follow up treatment in favour of Smt. Arifa Shantoo, I/C Assistant Registrar Induscose, Budgam outside the state at Rajiv Gandhi Cancer Institute, New Delhi, as per certificate issued by Director, Health Services, Kashmir vide No. MS/Gen/Med/Cert/3444 dated 31-10-2014 instead of Medanta the Medicity, Gurgoan, New Delhi wherefrom initial treatment was taken and re-imburement was sanctioned vide Govt. Order No 204-IND of 2014 dated 13-10-2014.

This is subject to the following conditions;

- i) That the certificate is obtained from the Competent Medical Authority to the effect that the condition of the patient was critical and could not wait for treatment in Medanta the Medicity, Gurgoan, where from initial treatment was taken.
- ii) That the Jammu and Kashmir Civil Services (Medical Attendance Rules-cum-Allowances) Rules, 1990 are applicable to the employee of INDUSCOS.
- iii) Re-imburement is restricted to the charges for the period of hospitalization from 14-01-2013 to 16-01-2013 at Rajiv Gandhi Cancer Institute, New Delhi, for items/procedures admissible under Rules and to the extent of the rates applicable to such items/procedures at AIIMS, New Delhi.
- iv) All relevant Medical vouchers/bills are verified and countersigned by the Competent Authority wherefrom the treatment has been received.
