Sanction is hereby accorded to the:-

1. Purchase of two vehicles (one Maruti Caiz Zeta Petrol and one Mahindra Bolero ZLX power plus 2WD) through State Motor Garages by Director, Industries and Commerce, Jammu; and
2. Advance drawal of Rs.20.00 lakhs (Rupees twenty lakhs only) for the above purpose under revenue budget 2017-18 in favour of Director, Industries and Commerce, Jammu.

The above sanction is subject to the following conditions:-

- a. The Purchase shall be effected through State Motor Garages.
- b. No post of Driver shall be created for the purpose.
- c. Purchase shall be made as per existing State car policy in vogue.
- d. Adequate and specific provision is available for the intended purchase under Revised Estimate 2017-18.
- e. The vehicle is not plied by any casual worker/daily wager;
- f. The red account of earlier advances (if any) shall be cleared on priority; and
- g. The expenditure shall be booked under appropriate head of account under revenue budget.
