Ex-post facto sanction is hereby accorded, in relaxation of the Jammu and Kashmir Civil Services (Medical Attendance-cum-Allowance) Rules, 1990, to the re-imburement of medical expenses incurred by Mr. Shakeel Ahmad Rather, ret'd. AHTO, Handicrafts Department on self treatment, at Institute of Liver and Biliary Sciences, New Delhi, subject to the following conditions:-

- a) Re-imburement of charges is restricted to items/procedures admissible under rules for the period of hospitalization w.e.f. 15.03.2017 to 24.04.2017 (including post-retirement period from 01.04.2017 to 24.04.2017) and cost thereof is restricted to the extent of rates applicable to such items/procedures at AIIMS, New Delhi.
- b) All relevant medical bills/vouchers are verified and countersigned by the competent medical authority of the hospital wherefrom treatment has been undertaken.
