- 5) Advance payment if any is to be made shall be adequately secured and properly guaranteed before the release of actual payment.

- i. Major head = 4851 – Capital Outlay on Village & Small Industries
- ii. Sub-Major Head = 00
- iii. Minor Head = 103-Handloom Industries
- iv. Group Head = 0011- General
- v. Sub-head = 0399-Handloom Dev. Corporation.
- vi. Detailed Head = 115-Works.
