- i- Withdrawal of an amount of Rs. 5.00 lakh (Rupees Five Lakh) only from Directorate of Industries and Commerce, Kashmir authorized vide letter No.Ind/Plan-1396/2017 dated: 04-07-2017 for the scheme "Upgradation/Maintenance of Office Complex at Sanat Ghar, Srinagar (Wi-fi, CCTV, Data Centre etc.) and system for online registration" under Capex Budget 2017-18;
- ii- Release / advance drawal of Rs. 5.00 lakh (Rupees Five Lakh) only in favour of Director Finance, Industries and Commerce Department for its further placement at the disposal of the Managing Director, J&K SICOP Ltd. for "Upgradation/Maintenance of Office Complex at Sanat Ghar, Srinagar (Wi-Fi, CCTV, Data Centre etc.) and system for online registration" under Capex Budget 2017-18.

The release / advance drawal is subject to the following conditions:-

1. The expenditure shall be incurred after observing all codal formalities;
2. The funds so released/advanced shall not be available for re-appropriation at any level.
3. Red Account/Utilization Certificate shall be submitted to the concerned quarters within stipulated period of time; and
4. The funds shall be utilized only after accord of Administrative Approval/technical sanction etc. as required as per the Book of Financial Code.

The expenditure shall be debited to following head of account:-

- b. Major Head = 4851 -Capital Outlay on Village & Small Industries
- c. Sub-Major Head = 00
- d. Minor Head = 102-Small Scale Industries.
- e. Group Head = 0011- General
- f. Sub-Head = 0407-Micro Small & Medium Enterprises.
