7. Any other relevant certificate as required under rules.

If on verification, the certificates produced by the appointee are
proved fake or forged, the appointment shall be cancelled ab-initio.

The appointee shall be on probation for a period of two years.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about his character antecedents is received from the Inspector General of Police, CID, J&K, to whom reference shall be made by the Director, Handloom Development Department, J&K.
