The Director, Handicrafts J&K shall allow them to join formally on the post against which they have been regularized only after checking the following certificates/documents in original.

1. Date of Birth Certificate.
2. Permanent Residence Certificate (PRC).
3. Academic Qualification Certificate.
4. Technical Qualification Certificate.

5. No Objection Certificate from DIC/Employment Exchange.
6. That these appointees have not been selected by any Recruiting Agency/or appointed in any other Government Department.
7. That the allowance(s) other than what was admissible/due has not been drawn.
8. That these employees are working against clear vacancies/ posts and have not been conveyed/recommended earlier by the Empowered Committee.

However, their salaries shall be drawn only after receipt of Character/antecedents verification report from CID (J&K Police).

The orders of regularization shall be subject to the cancellation ab-initio, in case, at any stage it emerges that the certificate/documents furnished by the appointees are fake/fictitious.
