ii. COLA/DA shall be paid at the rates, as was being paid to them and the subsequent release of COLA/DA shall be applicable to them as and when the same is released by the concerned Corporation/Organization.

iii. No arrears on account of pay or COLA/DA shall be paid in favour of these officials by the Government.

iv. The salary shall be released in favour of these officials from the date they join duties;

v. They shall retain lien in their parent Corporation/Organization.

vi. The above arrangement shall be reversible without any notice; and

vii. The posts vacated by the officials shall be deemed to have been frozen and shall not be filled up by promotion or by direct recruitment.
