Sanction is hereby accorded to the deputation / deployment of :

1. Mrs. Ayesha Sana Saigal, Assistant Extension Officer, DIC Kulgam to Government Arts Emporium, Bangalore of J&K Handicrafts (S&E) Corporation Limited for a period of one year.
2. Mr. Ghulam Nabi, Section Officer, J&K Cements Limited to Directorate of Industries and Commerce, Kashmir for a period of one year against the vacant post of Assistant Extension Officer or till the post is filled up on regular basis or till he is recalled, whichever is earlier.

Further, the salary of Mrs. Ayesha Sana Saigal, Assistant Extension Officer shall be drawn by the Directorate of Industries and Commerce Kashmir subject to furnishing of monthly attendance certificate. The salary of Mr. Ghulam Nabi, Section Officer shall be drawn and disbursed against the post of Assistant Extension Officer available on the overall cadre strength.

The deployment Mr. Ghulam Nabi, Section Officer shall be governed by the following terms and conditions:

- i. The salary of the official shall be drawn as per the LPC and without any deputation/deployment allowances;
- ii. Cola/DA shall be paid at the rates as being paid to him and the subsequent release of COLA/DA shall be applicable to him as and when the same is released by the concerned Corporation/Organization;

- iii. No arrears on account of pay or COLA/DA shall be paid in favour of the official by the Government;
- iv. The salary shall be released in favour of the official from the date he join duties;
- v. He shall retain lien in his parent Corporation/Organization;
- vi. The above arrangement shall be reversible without any notice; and
- vii. The post vacated by the official be deemed to have been frozen and shall not be filled up by promotion or by direct recruitment.
