Sanction is hereby accorded to the temporary appointment of Smt. Shafiqa Bano W/o Late Mohammad Shafi Reshi (Ex-Driver Grade-I) R/o Bagh-e-Sunder Payeen, Chattabal, Srinagar, as Orderly (Class-IV) State Cadre, in the Pay Level SL 1(14800-47100) in Directorate of Geology and Mining, J&K, in relaxation of prescribed qualification in terms of Rule-7 of SRO-43 of 1994.

The appointee shall report to the Director, Geology & Mining, J&K within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates to be verified subsequently:-

- i. Academic Qualification Certificate, if any.
- ii. Age and Health Certificate.
- iii. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- iv. All other relevant documents as are required under SRO-43/1994.
- v. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.

The appointee shall be initially on probation for a period of two years. If, on verification, the certificate(s) produced by the appointee prove to be fake or forged, the appointment shall be cancelled ab initio.

The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report about the verification of her character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Director, Geology & Mining J&K.



If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order she shall forego her right to appointment which shall be deemed to have been cancelled abinitio without any further notice.
