Following the merger of Handicrafts Department and Handloom Development Department into a single department with two Directorates at divisional-level vide above-referred Government Order and Administrative Council decision, it is hereby ordered that:

1. Directorate of Handicrafts, J&K, is re-designated as Directorate of Handicrafts & Handloom, Kashmir and Directorate of Handloom, J&K is re-designated as Directorate of Handicrafts & Handloom, Jammu.

2. Joint Directors of Handicrafts and Handloom Departments of the respective Divisions, along with their staff, will henceforth report to the Directorate of Handicrafts & Handloom in their Division and continue to function on 'as is where is basis'.

3. The officers and officials presently performing duties in erstwhile Directorates of Handicrafts and Handloom Development Department shall report for their duties in their respective Directorates of Handicrafts and Handloom, Jammu/ Kashmir respectively as per details attached at **Annexures I & II** to this order.

4. DDO powers in respect of the bifurcated staff of both the erstwhile Directorates will vest with the respective Directors of Handicrafts & Handloom, Jammu/ Kashmir and funds are allocated proportionately. Saddar Treasury Jammu and Saddar Treasury Srinagar are allotted to the respective Directorates for operation of REVEX/ CAPEX Budget.

Other than this afore-mentioned arrangement, modalities of merger (reorientation and restructuring) shall be put in place subsequently in terms of Government Order No.71-IND of 2020, dated 30.03.2020.
