Sanction is hereby accorded to constitution of Inspection/field visit team comprising of the following Officers under Industrial Development Scheme (IDS) 2017 for conducting the inspection of the unit wherein the investment in eligible Plant & Machinery is more than Rs. 20.00 crore.

- i. Representative of DPIIT, (which shall be deputed by DPIIT on intimation of Scheduled meeting)
- ii. Director Finance, Industries & Commerce Department.
- iii. Chief Accounts Officer, Directorate of I&C, (Jammu/Kashmir).
- iv. General Manager of concerned DIC.
- v. Representative from JKDFC.
- vi. Representative of Financial institution which has financed the project (in case of Bank Financed case).

The functions of the Inspection/Field visit Team shall be as follows:

- i) To verify the physical availability of the Plant and Machinery in respect of which claim has been made by the industrial unit.
- ii) To ascertain whether the components/items of these plant and machinery in respect of which subsidy claimed by the unit is as per the provisions of the scheme and subsequent clarifications issued from time to time.
- iii) To invariably consider the Appraisal Report of the Financial Institution(s) of the Industrial Unit along with other relevant documents while assessing the quantum of the value of Plant and Machinery.
- iv) To suitably explain the deviations (if any) in the value of Plant and Machinery considered eligible for subsidy from the Appraisal Report.
- v) To submit field visit report within 5 working days from the date of completion of field visit of the unit.
