Whereas, the department received a selection list of candidate for the post of "Jr. Scale Stenographer" (Industries and Commerce Department) State Cadre under Item No. 117/03 of 2012 from Secretary, J&K Services Selection Board, Jammu vide its No. SSB/Secy/05/S/2021/3870-76 dated 21.05.2021; **and**


Whereas, one candidate namely Nusrat Rafee D/o Mohd Rafee Khan R/o Diyarwani, Batamaloo, Srinagar was selected against the post of Jr. Scale Stenographer, advertised vide Notification No. 03 of 2012 dated 28.12.2012 under item No. 117 (OM) ; **and**

Whereas, the appointment order was issued by the Administrative Department in favour of selectee namely Nusrat Rafee D/o Mohd Rafee Khan R/o Diyarwani, Batamaloo, Srinagar against the post of Jr. Scale Stenographer vide Government Order No. 134-IND of 2021 dated 08.06.2021 with the directions to report in the office of Directorate of Handicrafts and Handloom, Kashmir within a period of 21 (twenty one) days from the date of issuance of order, failing which she shall forego her right to her appointment which shall be deemed to have been cancelled ab-initio without any further notice; **and**

Whereas, the Director, Handicrafts & Handloom, Kashmir vide communication No. DHHK/Estt/C/3967 dated 18.08.2021 intimated that the candidate namely Nusrat Rafee D/o Mohd Rafee Khan R/o Diyarwani, Batamaloo, Srinagar (appointee) did not joined in the Directorate of Handicrafts & Handloom, Kashmir till date; **and**

Whereas, the General Administration Department vide No. 08-JK(GAD) of 2019 dated 04.12.2019 issued circular instructions regarding inclusion of "Cancellation Clause" in the appointment order. The operative part of the circular is reproduced as under:-

"The candidates who fail to join within a period of 21 (twenty one) days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice".



Now therefore, taking the cognizance of non joining of the candidate and circular instructions issued by the General Administration Department, the appointment of Nusrat Rafee D/o Mohd Rafee Khan R/o Diyarwani, Batamaloo, Srinagar against the post of Jr. Scale Stenographer in the pay level 6 (35400-112400) advertised vide Notification No. 03 of 2012 dated 28.12.2012, under Item No. 117 (OM) appointed vide Government Order No. 134-IND of 2021 dated 08.06.2021 is hereby cancelled ab-initio.
