**Whereas**, the erstwhile Directorate of Handicrafts, J&K maintained the combined seniority list of Handicrafts Training Officers/ Quality Control Inspectors in respect of J&K prior to the merger of J&K Handicrafts Department and J&K Handloom Department; and

**Whereas**, consequent upon the merger of J&K Handicrafts Department and J&K Handloom Department into a single Department with two divisional level directorates notified vide, Government Order No. 71-IND of 2020 dated 30.03.2020, it has been felt expedient to maintain the combined seniority list of Handicrafts Training Officer/Quality Control Inspectors at the level of Administrative Department; and


**Whereas**, vide notification dated 08.11.2021, a tentative seniority list of HTOs/QCIs as stood on 01.01.2021 was issued by the department for inviting objections, if any, from the concerned within a period of 21 days from the date of issuance of notification; and

**Whereas**, the notification was given publicity through Directorate of Information and got published in leading dailies of Jammu (Daily Excelsior) and Kashmir (Tameel Irshad); and

**Whereas**, no objection, whatsoever has been received against the tentative seniority list from any quarter; and

Now therefore, a final seniority list in respect of HTOs/QCIs of Handicrafts department, J&K as it stood on 01.01.2021, is hereby issued forming Annexure "A" to this Government Order.

In case any officer feels aggrieved with the position assigned to him in the seniority list, he may file a review petition, as per the relevant provisions of the Jammu & Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956. The review petitions, if any, containing facts, as have not been considered or as have come to light now and which have a material bearing on the issue of determination of seniority, should reach this office within a period of one month from the date of issuance of this order failing which the seniority list shall be deemed to have attained finality.



The final Seniority List shall however be subject to the final outcome of the pending court case(s), if any.

The date(s) of birth recorded/indicated against the officials in the final Seniority List, shall not be taken as authentic, and, shall be subject to the verification from the Service Book/Matriculation certificate/other relevant record as prescribed under norms.


