1. All codal formalities shall be adhered to before drawal of funds.
2. Dy. Director (Planning)/ Chief Accounts Officer Directorate of Handicrafts & handloom, Kashmir, shall vouch safe availability of funds in the Capex Budget 2020-21.
3. Requisite utilization certificates/Red Account shall be submitted to the concerned quarters with a copy to the Administrative Department within stipulated time period.
4. The funds shall not be available for diversion/re-appropriation at any level.
5. DDO shall ensure adjustment of all previous accounts.
6. The funds shall be drawn if immediately required and should not be parked unnecessarily in the Bank account.
7. Necessary financial concurrence, AA/TS etc. wherever required, must be in place before booking the expenditure.

The expenditure shall be debited as per following classification.
