Revised Education Scheme for Children of Weavers/Artisans of Handicrafts & Handloom Departments.

OBJECTIVE:-

To provide scholarship in tune with present education scenario in the JK UT so that the scheme provides much needed financial support to the weavers/artisans in completion of education of their children.

ELIGIBILITY:

Children (both boys and girls) of all Weavers/Artisans registered with the Handicrafts and Handloom departments having valid registration card/certificate with following conditions:-

- Having Below Poverty Line (BPL), PHH, AAY ration card, (OR).
- Having Economic Weaker Section (EWS) Certificate, (OR).
- Having income less than 90,000 per annum with income certificate issued by 1st Class Magistrate/Tehsildar concerned.
- Before consideration for grant of Education allowances in favour of Children's of Weavers/Artisans under said scheme, the applicant shall seek NOC from concerned Zonal Educational Officer and Tehsil Social Welfare Officer, that He/She has not availed any benefit under the following schemes being implemented by these departments:
 1. Pre-Matric Scholarship
 2. Post-Matric Scholarship Scheme
 3. Prime Minister's Scholarship Scheme
 4. Any other scheme.

SCHOLARSHIPS:

The following amount of scholarship shall be provided to the eligible children of weavers/artisans.

S.No	Class	Rate of scholarship to each student
1	Upto Primary education	Rs. 1500 per student per year for boys and girls of weavers/artisans.
2	From 6th to 10th Class	Rs. 2000 per student per year for boys and girls of weavers/artisans.
3	From 11th to 12th Class-	Rs 3000 per student per year for boys and girls of weavers/artisans
4	For Technical/ Professional	As per actual course fee fixed by the Government.

Note: The scholarship shall be provided to maximum of two children of Weaver/Artisan.



METHOD OF DISBURSEMENT:

1. The payment shall be made on Direct Benefit Transfer (DBT) to the student after producing the valid fees receipt duly signed by the Head of Institution.
2. The student should enclose valid Registration Card issued by the Department during submission of scholarship application form.

SELECTION COMMITTEE:

The selection of beneficiaries under the Education Scheme for grant of Scholarships to the wards/children of Weavers/Artisans shall be made by the concerned Assistant Director in collaboration with his/her field staff after proper verifications for grant of scholarships to the children of eligible registered Weavers/Artisans as per target fixed during the financial year itself as per availability of funds. The Assistant Director of the concerned District shall seek the applications from the eligible registered Weavers/Artisans by issuing a notification in a leading daily newspaper/electronic media.
