6. That these appointees have not been selected by any Recruiting Agency/ or appointed in any other Government Department.
7. That the allowance(s) other than what was admissible/ due has not been drawn.
8. That these employees are working against clear vacancies / posts and have not been conveyed / recommended earlier by the Empowered Committee.

However, their salaries shall be drawn only after receipt of Character/ antecedents verification report from CID (J&K Police).


