1. The Director Handicrafts, Department shall fulfill all the required codal formalities/ procedures before incurring the expenditure.
2. The necessary red account shall be furnished to the Principal Accountant General J&K Srinagar soon after utilization.
3. The clearance certificate shall be obtained from Principal Accountant General in respect of O.B. items (if any) against Handicrafts Department.
4. The expenditure shall be made strictly according to the classification under which funds have been authorized by the Finance Department. No omissions/commissions or diversions shall be made under any pretext unless specifically and separately authorized.
5. Treasury Offices shall not entertain bills without complete classification under which funds have been placed with the Treasury.
6. Accounts officer of the Directorate of Handicrafts shall vouchsafe the availability of funds for the purpose.
7. The funds so released shall not have impact on code of conduct announced by Election Commissioner of India.
