5. *All other relevant documents as are required under-SRO-43/1994.*
6. *No loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.*

The appointee shall be initially on probation for a period of two years. If, on verification, the certificate(s) produced by the appointee are proved fake or forged, the appointment shall be cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report about the verification of her character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Director, Geology & Mining Department.
