Subject:- Extension of Pensionary benefits to the employees of the J&K Industries (JKI) and J&K Handicrafts Corporation (S&E) (JKHC,S&E) in terms of the Judgments of the Hon'ble High Court/Supreme Court.

Sanction is accorded to the acceptance of the recommendations of the Group of Ministers (GoM) constituted vide Govt. Order No. 1079-GAD of 2017 dated 21.08.2017 and extension of Pensionary benefits to the employees of JKI and JKHC(S&E) as per the decisions of the Hon'ble High Court/Supreme Court which shall be implemented as under:-

1. The respective Corporations shall prepare complete list of retired employees entitled for pension as per the Court orders, documenting their last pay drawn details, working out receivables such as employers share of CP Fund and the outstanding amount to be paid to bonafide retired employees and finalizing monthly pension in each case by the Managing Director, JKI and JKHC(S&E) expeditiously.
2. The Planning, Development and Monitoring Department shall arrange resources for funding the pension scheme to the extent there is outstanding towards already acquired land of JKI by the PW(R&B), ARI & Trainings and Culture Departments by way of re-appropriation of their CAPEX allocations for the FY 2017-18.
3. The JKI and JKHC(S&E) shall utilize atleast 50% of its receivables from resources other than received from the Planning Department, whether land compensation or profits at later stage for the payment of statutory liabilities and monthly pension.
