Sanction is accorded to the release/ advance drawl of Rs 15.00 lakh (Rupees Fifteen lakh) only by Director Finance, Industries & Commerce Department out of Capex Budget, 2017-18, J&K SICOP Ltd under the scheme "Up-gradation/Maintenance of Udyog Bhawan Jammu and Sanat Ghar, Srinagar (Wi-Fi, CCTV, data centre etc)" for its further placement with Managing Director, J&K SICOP for implementation of the scheme.

With this sanction, the total amount released under the scheme comes to Rs 30.00 lakh (Rupees Thirty lakh) till date.

The release/advance drawal of funds shall be subject to the following conditions:-

- i. the Managing Director, J&K SICOP shall utilize the funds only after completing all codal formalities required under rules;
- ii. no re-appropriation/diversion/retention of money is allowed in any case;
- iii. the utilization certificate of the funds released shall be submitted to Administrative Department soon after utilization;

Managing Director, J&K SICOP shall vouchsafe the utilization of funds.

The expenditure shall be debitible to the following object Heads:-

- ii. Major Head = 4852- Capital outlay on Iron & Steel Industries
- iii. Sub-Major Head = 02-Manufacture
- iv. Minor Head = 190- Investment in Public Sector & other Undertakings
- v. Group Head = 0011- State Plan Normal
- vi. Sub Head = 1224-SICOP
- vii. Detailed Head = 400-Plan Assistance
