As a follow up action of the decision taken in the Industrial Advisory Committee meeting held under the Chairpersonship of Hon'ble Chief Minister on 7th February, 2017, sanction is hereby accorded to the process to be initiated for registration of "**Jammu and Kashmir Trade Promotion Organization**" as a Company under the Companies Act, 2013.

The proposed Company with Head Quarter at Sempora near Joinery Mills Pampore shall be a Joint Venture between the Government of Jammu and Kashmir with 51% equity, the India Trade Promotion Organization (ITPO)- a Government of India Undertaking with 44% equity and the Export Promotion Council for Handicrafts (EPCH) - a Government of India Undertaking with 5% equity.

The Director Finance, Industries and Commerce Department, Shri Rajesh Chander Kotwal is nominated as Nodal Officer for the process of incorporation of the Company.
