Sanction is accorded to the advance drawl of an amount of Rs. 300.00 Lakh (Rupees Three Crore only) for the Financial Year 2019-20 authorized by the Finance Department vide No.FD-VII-11(124) 2005 dated 13-09-2019 in favour of Director Finance, Industries & Commerce Department for further placement of these funds at the disposal of Director, Entrepreneurship Development Institute falling under the Administrative control of Industries & Commerce Department for meeting the funds under salaries and other authorized expenditure of the Institute.

With this sanction, the total amount released in favour of Director, Entrepreneurship Development Institute for the financial year 2019-20 comes to Rs.600.00 Lakh (Rupees Six Crore only).

The above authorization/advance drawl is subject to the fulfillment of the following conditions by the Director, J&K-EDI:-

1. Director EDI, shall vouchsafe the availability of fund.
2. Funds shall be utilized for the specific purpose for which these have been released.
3. The Director, EDI shall ensure that the funds released are utilized prudently and judiciously under rules and in no case the Institute should book the expenditure just for the sake of spending.
4. All codal formalities and financial rules/orders and instructions issued by the Government from time to time shall be observed while incurring the expenditure against the allocated budget.
5. The Director, EDI shall submit utilization certificate of the funds released soon after the utilization.
6. No re-appropriation/diversion/retention of funds is allowed in any case.
7. The ceiling under above authorized Object Head shall be kept within the authorized/allocated funds for financial year 2019-20 .
8. UC's/Red accounts of the funds being released shall be furnished to all the concerned quarters including Principal Accountant General, J&K.
