- 4 The Director, EDI shall submit utilization certificate of the funds released soon after the utilization.
- 5. No re-appropriation/diversion/retention of funds is allowed in any case.
- 6. The ceiling under above authorized Object Head shall be kept within the authorized/allocated funds for financial year 2018-19.
- 7. UC's/Red accounts of the funds being released shall be furnished to all the concerned quarters including Principal Accountant General, J&K.
