Sanction is hereby accorded to the release of Rs.640.00 lakh ( Rupees Six crore forty lakh) only on account of 3<sup>rd</sup> installment of Grant-in-Aid in favour of Secretary Khadi & Village Industries Board J&K, Jammu to defray expenses on account of salary, pension etc of its employees during the current financial year 2019-20.

Sanction is also accorded to the advance drawal of the said amount of Rs.640.00 lakh (Rupees Six crore forty lakh) only by the Director Finance, Industries & Commerce Department for its further placement at the disposal of Secretary/CEO J&K Khadi & Village Industries Board. The expenditure shall be booked by Secretary/CEO J&K, KVIB after fulfillment of the following conditions:-

1. There shall be no diversion/deviation in any case.
2. Before incurring expenditure all codal provisions shall be completed .
3. The accounts of the institution shall be open for test check by Accountant General and Finance Department at any time.
4. No vacant post shall be filled up either by promotion or by direct recruitment.
5. The expenditure shall be made on admissible items only as approved by the competent authority.
6. The funds shall not be drawn just to park in the bank account but incurred for the purpose they are ment for.
7. Expected income and expenditure details for the current financial year be furnished to the Administrative Department / Finance Department.
8. The UC's shall be furnished to the AG's office within stipulated time.
9. The Chief Accounts Officer, J&K KVIB shall vouchsafe the availability of funds.
