In continuation to Government Order No.241-Ind of 2018 dated: 16-10-2018, sanction is hereby accorded to the release/ advance drawal of funds amounting to Rs.722.50 Lakh (Rupees Seven Crore Twenty-two lakh and Fifty Thousand) only of the Capex Budget, 2018-19 in favour of Director Finance, Industries and Commerce Department for its further placement at the disposal of Director, J&K Entrepreneurship Dev. Institute for implementation of approved schemes of Capex Budget 2018-19.

The total releases thus made during the current financial year works out to Rs.1472.50 lakh.

The advance drawal is subject to the following conditions:-

1. The amount is utilized only on approved schemes duly authorized by the Board of Directors of the Corporation;
2. No expenditure is incurred on any scheme / project, if not administratively approved and technically vetted by the competent authority;
3. Director Finance, I&C shall vouch safe availability of funds under Capex Budget 2018-19.
4. No diversions are made and all codal / procedural formalities are adhered to before utilizing the funds;
5. Red account/ utilization certificate shall be submitted to the concerned quarters within stipulated time but before 31-03-2019.
6. Advance payment if any is to be made shall be adequately secured and properly guaranteed before the release of actual payment.

The expenditure shall be debit able to the object Heads:-
