Sanction is accorded to the advance drawl of an amount of Rs.350.00 Lakh (Rupees Three crore fifty lakh) only for the Financial Year 2018-19 authorized by the Finance Department vide No.FD-VII-11(124) EDI-I dated 27.03.2019 in favour of Director Finance, Industries & Commerce Department for further placement of these funds at the disposal of Director, Entrepreneurship Development Institute falling under the Administrative control of Industries & Commerce Department for meeting the salaries and other authorized expenditure of the Institute.

The above authorization/advance drawl is subject to the fulfillment of the following conditions by the Director, J&K-EDI:-

1. The funds shall be utilized on above committed items for the bonafied purpose only with the approval by the Governing Body of the Institute.
2. The Director, EDI shall ensure that the funds released are utilized prudently and judiciously under rules and in no case the Institute should book the expenditure just for the sake of spending.
3. All codal formalities and financial rules/orders and instructions issued by the Government from time to time shall be observed while incurring the expenditure against the allocated budget.
4. The Director, EDI shall submit utilization certificate of the funds released soon after the utilization.
5. No re-appropriation/diversion/retention of funds is allowed in any case.
6. The ceiling under above authorized Object Head shall be kept within the authorized/allocated funds for financial year 2018-19 .
7. UC's/Red accounts of the funds being released shall be furnished to all the concerned quarters including Principal Accountant General, J&K..
8. A detailed presentation on achievements of EDI be made before the Principal Secretary to Government, Finance Department.
