Subject: - Extension in validity of selection/waiting list for the post of "Junior Craft Instructor (Sozni)", District Cadre, Ganderbal, advertised under item No. 298 (03 of 2012 dated 28.12.2012).

WHEREAS, the J&K Services Selection Board furnished recommendation for appointment of candidates against the post of Junior Craft Instructor (Sozni), District Cadre Ganderbal advertised under item No. 289 (03 of 2012 dated 28.12.2012) vide letter No. SSB/Secy/Sel/2018/823-29 dated 17.01.2018;

AND WHEREAS, the recommendations of the J&K Services Selection Board were forwarded to Director Handicrafts vide letter No. IND/DOH/21/2018 dated 15.02.2018 with advice to issue formal appointment order in favour of the 02 selected candidates, under Open Merit and RBA Category, after observing all necessary formalities required under rules;

AND WHEREAS, one Mr. Manzoor Ahmad Lone figuring at S.No 1 in the waiting list under OM Category represented seeking operation of waiting list for the post of "Junior Craft Instructor (Sozni)" becoming available due to non-joining of one Ms Surya Tabasum who had already joined as "Junior Craft Instructor (Namdha)";

AND WHEREAS, the Director Handicrafts Department vide letter dated 16.01.2019 informed that Ms. Suraya Tabasum was selected against the post of Junior Craft Instructor (Sozni) as well as Junior Craft Instructor (Namdha), District Cadre Ganderbal advertised by the J&K Services Selection Board vide item Nos. 289 and 290, respectively. Ms. Surya Tabasum was appointed as Jr. Craft Instructor (Namdha) vide order No. 182-HD of 2018 dated 27.02.2018. The appointment order against post of Junior Craft Instructor (Sozni) could not be issued in view of Court Order dated 10.01.2018 passed in SWP No. 14/2018-titled Manzoor Ahmad Lone V/S State and others;

AND WHEREAS, the scrutiny of the documents, however, revealed that the Directorate of Handicrafts had issued two appointment orders in favour of Ms. Surya Tabasum D/o Mohd Kaskari R/o Ganderbal. She was appointed as Junior Craft Instructor (Namdha) vide



Order No. 182-HD of 2018 dated 27.02.2018 and Junior Craft Instructor (Sozni) vide Order No. 331-HD of 2018 dated 16.04.2018. It further revealed that Ms Surya Tabasum had joined the Handicrafts Department as Junior Craft Instructor (Namdha) and is continuing on the said post;

AND WHEREAS, due to oversight, the waiting list furnished by the J&K Services Selection Board with regard to the post of Junior Craft Instructor (Sozni) couldn't be operated upon within the prescribed period of one year i.e upto 17.01.2019 for appointment of Mr. Manzoor Ahmad Lone S/o Habibullah Lone R/o Hatbara Ganderbal;

AND WHEREAS, the Director Handicrafts cancelled the selection/appointment of Ms Surya Tabasum as 'Junior Craft Instructor (Sozni)' vide Order No. 438-HD of 2019 dated 18.09.2019;

AND WHEREAS, in view of the representation of Mr Manzoor Ahmad Lone, the matter was taken up with the General Administration Department seeking revalidation of the select/wait list for the post of Junior Craft Instructor, (Sozni) District Cadre Ganderbal forwarded by the Services Selection Board vide letter dated 17.01.2018, in relaxation of Rule 14(7) of the Jammu and Kashmir Civil Services Decentralization and Recruitment Rules, 2010;

AND WHEREAS, the General Administration Department has conveyed the approval of the Competent Authority to the departmental proposal vide U.O No. GDC-60/CM/2019 dated 06.01.2020. It has been further advised to initiate regular departmental action (RDA) against the officials responsible for submitting incorrect information to the department;

AND WHEREAS, the matter has been examined further and it has been decided to issue a speaking order in the matter.

NOW, THEREFORE, sanction is hereby accorded to the:

- (i) revalidation of waiting list for the post of "Junior Craft Instructor (Sozni), drawn by the Jammu and Kashmir Services Selection Board vide No. SSB/Secy/Sel/2018/ 823-29 dated 17.01.2018 beyond the date of its expiry (16.01.2019) upto 31st January, 2020 for appointment of Mr. Manzoor Ahmad Lone S/o Habib Ullah Lone R/o Hatbara, Ganderbal, figuring at S.No. 1 in the waiting list in relaxation of Rule 14(7) of the Jammu and Kashmir Civil Services Decentralization and Recruitment



Rules, 2010 notified vide SRO 375 dated 21.10.2010.

- (ii) initiation of regular departmental action against the officials of Handicrafts Department, J&K responsible for submitting incorrect information in the matter to the Administrative Department.


