Sanction is hereby accorded to the release of Rs.500.00 lakhs ( Rupees Five Crore ) only on account of 2<sup>nd</sup> installment of Grant-in-Aid in favour of Secretary/CEO Khadi & Village Industries Board J&K, Srinagar/Jammu to defray expenses on account of salary only during the current financial year 2020-21.

Sanction is also accorded to the advance drawal of the said amount of Rs.500.00 lakh (Rupees Five Crore) only by the Director Finance, Industries & Commerce Department for its further placement at the disposal of Secretary/CEO J&K, Khadi & Village Industries Board, Srinagar /Jammu. The expenditure shall be booked by Secretary/CEO J&K, KVIB after fulfillment of the following conditions:-

1. Secretary Khadi & Village Industries Board shall vouchsafe the availability of funds.
2. The Expenditure shall be booked on salary & other items only as approved by the competent authority.
3. The funds shall be utilized for purpose the meant for , without any deviation or diversion.
4. The accounts of the institution shall be open for test check by Accountant General and Finance Department at any time.
5. No vacant post shall be filled up either by promotion or by direct recruitment.
6. Reduce the expenditure on TE, OE, POL by 15% of last year's level.
7. No vehicle shall be purchased during the current financial year.
8. All the UC's /Red Accounts of the previous amount if any pending shall be submitted to the AG on priority and the OB items if any pending for want of UC's/ Red Accounts of previous amounts shall be cleared from the AG's office immediately.
