WHEREAS, vide Government order NO:101-IND of 2015 dated: 02-07-2015, final Seniority List of Assistant Directors of Handicrafts, as it stood on 01-01-2015, was notified; and

WHEREAS, the Seniority List is required to be up-dated by excluding the names of the officers, who have either promoted to the next higher post substantively or have retired on superannuation or have been inducted into J&K Administrative Service and include those who have been appointed to the post of Assistant Director, by direct recruitment or promotion; and

WHEREAS, after issuance of the said seniority list, a number of Assistant Directors (Promotee), appointed in incharge capacity since 2008 in the Handicrafts Department, have been promoted on substantive basis through DPC/JKPSC vide Government Order No: 38-IND of 2019 dated: 26-02-2019. The seniority of such incumbents is required to be fixed and notified in the seniority list of the Assistant Directors Handicrafts; and

WHEREAS, a tentative seniority list of the Assistant Directors of Handicrafts Department, as it stood on 01-12-2019 was issued vide Government Order NO: 300-IND of 2019 dated: 27-12-2019 inviting objections viz-a-viz the assigned inter-se-position, if any, from the concerned members within a period of 15 days from the date of issuance of the tentative seniority list; and

WHEREAS, no objections have been received in the department from any member of the service within the stipulated time.

Now, therefore, a final seniority list of the Assistant Directors of Handicrafts Department, as it stood on 01-12-2019, forming Annexure to this Government order, is hereby issued. The seniority shall be subject to the outcome of writ petition(s), if any, pending before any competent court (s) of law. The date of birth recorded in the seniority list shall not be taken as authentic and shall be subject to verification from Service Book /Matriculation certificate of the concerned officer.


