The deployment of these officials, shall, however, be governed by the following terms and conditions:-

- i. The salary of these officials shall be drawn as per the LPC and without any deputation/ deployment allowance;
- ii. COLA/DA shall be paid at the rates, as was being paid to them and the subsequent release of COLA/DA shall be applicable to them as and when the same is released by the concerned Corporation/ Organization.
- iii. No arrears on account of pay or COLA/DA shall be paid in favour of these officials by the Government.
- iv. The salary shall be released in favour of these officials from the date they join duties;
- v. The salary shall be released in favour of these officials from the date they join duties;
- vi. They shall retain lien in their parent Corporation/ Organization.
- vii. The above arrangement shall be reversible without any notice; and
- viii. The posts vacated by the officials shall be deemed to have been frozen and shall not be filled up by promotion or by direct recruitment.


