Sanction is hereby accorded to the release of **Rs.848.00 lakhs (Rupees Eight Crore forty-eight lakh) Only** on account of 3rd installment of Grant-in-Aid in favour of Secretary/CEO Khadi & Village Industries Board J&K, Srinagar/Jammu to defray expenses on account of salary only during the current financial year 2020-21.

Sanction is also accorded to the advance drawal of the said amount of Rs.848.00 Lakh (Rupees Eight Crore Forty Eight Lakh only) by the Director Finance, Industries & Commerce Department for its further placement at the disposal of Secretary/CEO J&K, Khadi & Village Industries Board, Srinagar /Jammu. The expenditure shall be booked by Secretary/CEO J&K, KVIB after fulfillment of the following conditions:-

1. Secretary Khadi & Village Industries Board shall vouchsafe the availability of funds.
2. The expenditure shall be made for release of only salary of the employees of KVIB with approval of competent authority.
3. The expenditure shall be made after observing all the required codal formalities.
4. There shall be no diversion/deviation in any case and funds shall be drawn, if immediately required and not just to park in the bank account.
5. The UCs/RDC accounts shall be furnished to the concerned quarters within stipulated time.
