Subject: - Deployment of employees of J&K Cements Limited.

Sanction is hereby accorded to the temporary deployment of Sh. Manzoor Hussain General Manager (Token No. 1000) and Sh. Shuja Mahdi Khan, Manager (Token No. 1040) J&K Cements Limited to the Directorate of Geology & Mining, J&K, Jammu for further duties for a period of one year or till the post are filled up on regular basis or till the officers are recalled whichever is earlier subject to the following conditions:-

- i. The salary of these officers shall be drawn by the Department of Geology & Mining, J&K, Jammu as per the LPCs issued by the Managing Director JKCL and without any deputation/deployment allowance.*
- ii. COLA/DA shall be paid at the rates, as was being paid to them and the subsequent release of COLA/DA shall be applicable to them as and when the same is released by the concerned Corporation.*
- iii. No arrears on account of pay or COLA/DA shall be paid in favour of these officers.*
- iv. The salary shall be released in favour of these officers from the date they join duties.*
- v. They shall retain their lien, seniority and promotion prospects at their parent Corporation viz. JK Cements Limited.*
- vi. These officers shall remain on the rolls of J&K Cements and shall not opt for the Golden Handshake Scheme which shall be certified by the concerned Organization.*
- vii. The above arrangement shall be reversible without any notice;*
- viii. The posts vacated by these officers in J&K Cements Limited shall be deemed to have been frozen and shall not be filled up by promotion or by direct recruitment.*
- ix. The officers so deployed shall furnish an undertaking duly attested by the 1st Class Magistrate stating therein that they have no right to claim for permanent absorption in the department and will not approach any Hon'ble Court of Law for the said purpose.*
- x. The Pay level and designation shall not be taken as authentic and shall be subject to further verification by Managing Director JKCL in their LPCs to be issued by him.*
