5. The Institute shall furnish income/expenditure statement alongwith bank statement before seeking further release of fund.
6. UC's/Red accounts of the funds being released shall be furnished to all the concerned quarters including Principal Accountant General, J&K..
7. J&K , Entrepreneurship Dev. Institute (EDI) must ensure holding of meeting of its Governing Body and further release of Grant-in-Aid shall be subject to conduct of meeting of Governing Body of the said Institute.
