Subject: Stop-gap arrangement in Jammu & Kashmir Handicrafts (Gazetted) Service.

Sanction is hereby accorded to the placement of following officials of the J&K Handicrafts (Subordinate) Service as Incharge Assistant Director Handicrafts, in their own pay and grade, with charge allowance, as admissible under rules, for a period of six months or till the available vacancy in the J&K Handicrafts (Gazetted) Service is filled up, on regular basis, on the recommendations of the DPC/PSC, whichever is earlier:

The above arrangement shall not, however, confer any preferential right upon the officers for consideration of promotion as Assistant Director, as and when, the same is considered on regular basis and shall be subject to the out come of writ petition(s), if any, pending consideration before any competent court(s) of law.

Consequent upon the above, the following transfers and postings are hereby ordered with immediate effect:-

- (i) Ms. Tsering Dolma, Incharge AD, awaiting orders of posting, is transferred and posted as Assistant Director Handicrafts Ganderbal. She shall also hold the charge of the post of Assistant Director Handloom Ganderbal, in addition to her own duties, till further orders.
- (ii) Mr. Joginder Mangol, on his placement as incharge Assistant Director Handicrafts, is transferred and posted as Deputy Registrar, Induscose Jammu.
- (iii) Mr. Bashir Ahmed Mir on his placement as Incharge Assistant Director Handicrafts is transferred and posted as Incharge Assistant Director Handicrafts Budgam. He shall also hold the charge of the post of Assistant Director Handloom Budgam, in addition to his own duties, till further orders.

Further, Mr. Kashif Altaf Bhat, Assistant Director Handloom Kupwara shall also hold the charge of the post of Assistant Director Handicrafts Kupwara, in addition to his own duties, till further orders.
