3. The expenditure shall be booked on approved items and with approval of competent authority.
4. The funds shall be drawn if immediately required and should not be parked unnecessarily in the Bank account.
5. Necessary financial concurrence, AA/TS etc. wherever required, must be in place before booking the expenditure.
6. The detailed Red DC Account of the advance drawal shall be furnished to all the concerned quarters within stipulated time but before 31.03.2021.
